citizens. Dr. Buchanan has been at the Health Department since 2004 and oversees a staff of 187 with oversight of:

- The Women's Health Clinic that provides annual Pap smears, breast exams and contraceptives to uninsured women as well as routine wellness checks for uninsured women.
- The Preventive Health Clinic that gives child and adult vaccinations and routine vaccinations as well as the seasonal flu and H1N1 flu vaccines.
- The Communicable Disease Program where patients can get tested for sexually transmitted diseases and tuberculosis and treated free of charge.
- A program in which nurses track cases that seem to be connected to diseases such as E. coli, whooping cough or meningitis, which can lead to a Health Department outbreak investigation to

find the common thread among those with the disease.

- Children's Special Services for children with medical disabilities who need a wheelchair or a feeding tube.
- The Adult Primary Care program for homeless and the indigent of Knox County.
- Dentistry and pharmacy programs.

Dr. Buchanan was in family practice before coming to the Knox County Health Department, but left her practice to pursue a broader mission. As she said in the Knoxville News Sentinel profile of Nov. 23, 2009, "We were told we need to see more (patients) and do more," she said. "It's hard to look at their vacation pictures when you don't have the time. Now I see the whole community as my patient." Homeless Housing Plan: League Working Group Forming

Knox County's 10-year Plan to End Homelessness calls for providing permanent supportive housing

for men and women who are chronically homeless. The plan targets those individuals who are disabled, typically as a result of untreated mental illness, substance abuse, or a combination of these problems and who have had at least four instances of homelessness within three years. For these people, homelessness involves much more than a lack of housing - it's also the result of insufficient or uncoordinated social services. They need housing in order to succeed in a treatment program, and a treatment program in order to be stable enough to stay in housing. To address this problem, the County is taking a "Housing First" approach by seeking to provide housing with integrated supportive services and without preconditions. To accomplish this, the 10-Year Plan calls for building new housing projects dispersed in communities throughout the County.

Unfortunately, the County has faced substantial opposition every time it has attempted to site a new project. Some neighborhoods complain that they already have too many programs serving the homeless, while others complain that bringing in such programs to new areas would harm their communities. Recently, Knox County Commission voted down a proposed housing site in the Farragut area in response to vocal opposition by neighbors.

The LWVKKC has already adopted a policy position in support of permanent supportive housing for mentally ill persons, and the national League has a policy in support of providing a decent home for all Americans. The LWVKKC is now exploring whether to adopt a more specific position statement regarding siting of these programs. Stephanie Matheny, a new League member who developed housing for the homeless in the Seattle area for 11 years, has agreed to convene a group to work on this issue. League Speaks Out on Election Recall Process

The League has been following the debate over changing the process for recall elections. A change

in the County charter would be necessary and must be approved by County Commission. Barbara Nicodemus is observing County Commission for the Observer Corps and brought the issue to our attention. Based on the League's national position that elections be fair and equitable, Barbara prepared a report for the League board and a statement of our position to be read to County Commission. President Jamey Dobbs read the statement in the Commission's open public forum on Monday, Jan. 4.

Our local League is advocating that a lower threshold of signatures be required to get a recall election option placed on the ballot. Under the proposal initially submitted to Commission, over 30,000 signatures from registered voters would be required on a petition to bring a recall to the electorate for a county wide elected official—that is using the current minimum basis of 25% of all voters in the last gubernatorial election. This number of signatures would be difficult for any citizen's group to gather without expensive paid staffing and thus remove the option for ordinary citizens. We recommend lowering this threshold using the proposed basis of either 15% of votes cast in the last gubernatorial election or 50% of the votes cast in the election of the official being considered for recall.

Another Commission public forum is scheduled for Tuesday, Jan 19th at 5:00 pm in the Main Assembly Room of the City County Building. Barbara Nicodemus will attend and reiterate our position on behalf of the League. More information from the meetings can be found at the League website under Observer Corps.

Proposal to Develop a National Position on the U.S. Financial Crisis of 2006 to Current

What happened in the AIG & big investment bank bail out of 9/08 and why are we still without reform to prevent another financial collapse? I would like LWVUS to study, form a position, and advocate for finance reform in Congress. I propose that a group from the LWVKKC develop a program study proposal and submit it to the national convention in June. The deadline for proposals is soon, March 1.

To illustrate part of the problem, the carried interest rule allows Investment Bank CEOs to claim their multi-million dollar bonuses as 15% capital gains income rather than earned income subject to payroll & regular income tax rates. They are getting bonuses for profits investing other people's money, often for very brief time periods. This year they are getting bonuses because taxpayers are buying their toxic assets and giving them nearly free Federal Reserve loans for leveraged investments. They are not placing their own money at risk for over 3 years, which is the standard for a regular citizen to define a capital gain.

I propose the national LWV study the interplay of the Federal Reserve, FDIC and financial sector in steering our economy. I fear the greed and lobby dollars of Finance & Banking special interests dictate the U.S. financial laws steering our economic system. The issues that need more public, less banking interest include: regulation of dark derivatives, separation of commercial/retail

banks from investment banks, FDIC insurance for commercial/retail banks in a separate system from any protections or reinsurance for investment banks, Federal Reserve scrutiny regarding interest and loans to investment banks, leverage rules for all banks and financial firms, better disclosure for all financial products (including mortgages, credit cards, stocks, mutual funds, pension funds, banking, risk reinsurance as AIG sold), fair taxation of financial industry activity and pay, breaking up 'too-big-to-fail' institutions, TARP and stimulus spending & impact on the national debt.

Although it sounds 'too-big-to-tackle', 'many hands' makes the difference. I call on the Knoxville League to form a program proposal to submit to the June LWVUS convention.
